StanChem SC 6300 Expected Performance

ASTM C156 Water Retention

Modified C156 Test Procedure: 460.0 grams of mortar mix (consisting of 14 parts water to 100 parts dry concrete mix) were added to a silicone mold (dimensions 9.8 cm x 9.8 cm x 1.8 cm deep). The mixture was allowed to dry until the surface could be coated with cure & seal sample.

1.92 grams of the sample were applied, equal to an application rate of 5.0 m²/liter. Weight loss was monitored for 72 hours, with a target loss of less than 0.55 kg/m² (per the requirements of ASTM C309)

StanChem SC 6380 Clear Cure & Seal achieved a weight loss of 0.51 kg/m²
